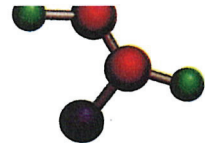

### Description

Miticide. A proprietary blend containing rosemary oil for control and repellence of spider mites. This product is intended for the prevention and treatment of spider mites on all plants including food crops.

Listed by the Organic Materials Review Institute (OMRI) for use in organic production.

### Ingredients

Active Ingredients: Rosemary oil (50%), Clove oil (3%), and Peppermint oil (1.95%).....	54.95%
Inert Ingredients: Glycerol monooleate, Ethyl lactate, Ascorbyl palmitate.....	45.05%

### Directions

READ ENTIRE LABEL – USE IN ACCORDANCE WITH LABEL INSTRUCTIONS.

THIS PRODUCT IS A CONCENTRATE AND MUST BE DILUTED BEFORE USING. Use dilution immediately – Do not store diluted solution. NOTE: This product is intended to be combined with an approved wetting adjuvant or surfactant. For best results, use with an approved wetting adjuvant or surfactant. Dilute TetraCURB Organic at 32 – 256 fluid ounces per 100 gallons of water and spray plants to achieve complete coverage until runoff.

MIXING DIRECTIONS: Fill a clean tank with half of the amount of needed clean water. Add TetraCURB Organic for the desired rate of application. Fill the tank with the remaining amount of needed water and mix to obtain a homogenous mixture.

APPLICATION DIRECTIONS: Apply the mixture using a clean sprayer to achieve complete coverage until runoff.

NOTE: Since plant varieties are numerous and may react differently to TetraCURB Organic, test the product on a small scale before making large-scale applications. Do not apply on plants when the temperature is 90° F or above.

### Precautionary Statements

### Storage and Disposal
